Rules, Terms, and Conditions

REGISTRATION FEE

All **New** Students will be charged a one-time \$50 non-refundable registration fee. This fee does not expire.

SUPERVISION

Supervision of your child/children is your responsibility before and after lessons.

Parents/Guardians are required to be on the premises at all times.

Running and playing on the pool deck is prohibited.

For safety reasons, please sit your child on the pool edge and hold onto him/her until the instructor takes him/her into the pool. At the conclusion of the lesson, the instructor will have your child climb out of the pool. Please be waiting with a towel.

FEEDING GUIDELINES

Children may swallow air and water during their lesson. If they have eaten immediately before their lesson, they may spit up recently eaten food which is uncomfortable for the child. **Please DO NOT feed your child directly before their lesson.**

Avoid hard to digest foods such as meats, beans, nuts and dairy products at **least four (4) hours** before the lesson. This includes formula, milk, eggs, vegetables, cheese and yogurt.

Breast milk, toast, cereal (without milk), crackers, graham crackers, peanut butter or other easily digested foods may be given two (2) hours before the lesson.

SWIM DIAPERS

Any swimmer who is **NOT** potty trained must wear one disposable swim diaper **and** one reusable swim diaper.

Children ages 4 and under who are “potty trained” may omit the disposable diaper but must wear a properly fitted cloth, reusable swim diaper. **Happy Nappy usable swim diapers are great and are available on Amazon and at Wal-Mart.**

A FEE of \$250 will be assessed if your child has an accident in the pool and is NOT wearing the proper attire.

MAKEUP POLICY

All swimmers will be allowed one **(1) make-up lesson per month** for excused absences in advance (3 hours prior to class start). Please notify Little Swimmers of Georgia, LLC of any expected or planned absences via email at swim@littleswimmersofgeorgia.com or via text at 813-422-1534. **Expected or planned absences will be rescheduled based on availability. Make-up lessons will have a 90-day expiration.**

Photography/Video
